# 2023 - 2024 PROPOSED BUDGET | What You Need to Know

The District budget vote, along with the Board of Education election, will be held on **May 16**, **2023.** If the proposed budget is passed by voters, it will be enacted for the 2023-24 school year.

# TO VOTE YOU MUST BE: TO VOTE YOU:

- A U.S. citizen - Do NOT have to own property

- A resident of Dundee Central School District - Do NOT have to be a parent/guardian

- At least 18 year old - Do NOT have to have children in the school

- Registered to vote with the Yates County or district

# **BOARD OF EDUCATION ELECTION**

There are three (3) candidates running for three (3) seats, each term will be for three (3) years. The candidates will appear on the ballot in the following order:

# **PROPOSITIONS ON THE BALLOT**

# **Budget Proposition**

RESOLVED, that the Board of Education of the Dundee Central School District adopt a proposed budget in the amount of \$21,177,813 (increase of 4.65%) for the school year 2023-2024 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the district.

# **Transportation Vehicles**

RESOLVED, that the Board of Education of the Dundee Central School District be authorized to purchase two (2) transportation vehicles, including related furnishings and equipment incidental thereto and expend therefore a total sum not to exceed \$330,000 which is estimated to be the total maximum cost thereof, and pay for such vehicles by the use of funds from the 2019 Bus Purchase Reserve Fund in an amount not to exceed \$330,000, with no tax levy impact.

## PROPOSITIONS ON THE BALLOT, CONTINUED


#### 2023 Capital Reserve Fund

RESOLVED, that the Board of Education be authorized to establish a new ten-year capital reserve fund pursuant to Section 3651 of the Education Law and fund such fund in an amount not to exceed \$5,000,000, inclusive of accrued interest and other investment earnings, to be used for construction reconstructions, renovations, improvements and additions to all District facilities, including purchase of student transportation vehicles, equipment, technology upgrades, classroom equipment and/or school infrastructure equipment, site development, athletic fields, playgrounds, storm and sanitary sewer, driveways, and parking lots, such reserve fund to be funded from (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ended June 30, 2023 and each fiscal year thereafter for the term of the reserve fund (ii) transfers of excess monies from Board of Education designated reserves, (iii) amounts from budgetary appropriations from time to time, and (iv) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law.

#### **Dundee Library Tax Levy**

RESOLVED, that the Board of Education of the Dundee Central School District be and hereby is authorized to enter into a "Contract for Educational Services" with the Dundee Library in the amount of \$173,000 and to levy the necessary tax for the above purpose. (The current annual library appropriation is guaranteed at \$168,000. Approval of the proposition would ensure additional funds of \$5,000 for future years.)

# 2023—2024 ANTICIPATED REVENUES AND PROPOSED EXPENDITURES





# **Making Sense of Your Tax Bill**

How will the proposed 2023-24 budget affect your taxes?

Dundee Central School District is proposing an increase to its tax levy of 2.85% for 2023-24. However, your overall tax bill may change by a different percentage if:

- The value of your property has changed;
- Your STAR reimbursement has changed; or
- The proportion of school taxes paid by homeowners in your township changes.

How is your final school tax bill & tax rate set?

**School Tax Levy::** Amount a school district needs to collect from property owners each year.

**State School Tax Relief Program (STAR):** Partial school tax exemptions for owner-occupied homes. The Basic STAR and Enhances STAR savings for each township can be found at www.tax.ny.gov/pit/property/star/ex\_index.htm.

**Property Assessments:** Estimate of the value of how much a property would sell for under normal conditions. This is determined by your town's assessor.

Once all factors are set, the final tax rate determines how much of the total tax levy each property owner pays.

# The Dundee Library

The Dundee Library Board of Trustees has voted to request an increase of \$5,000 for the 2024 fiscal year. The total amount requested is \$173,000. This is under the tax cap set by the State. Costs continue to rise especially in the areas of utilities and payroll. The minimum wage has risen \$2.00/hour in the last two years and it is expected to go up again. The Library is also required to pay for sick leave and family medical leave for employees. The Dundee water bill has increased due to the charges for the waste water treatment. Library circulation is going up and the number of users is up. Many community organizations are cooperating in programs for all ages including children, veterans, caregivers and the disabled. The Tripp Community Room has been reserved almost 100 times since December 2022 by community members.
